Master of Physiotherapy courses of KUHS for the academic year 2024-25.

Students applying admission for BPT/MPT programmes should note;

1. The Cut-off date for allotment of Government merit quota seats and closing of admissions entitling Management to collect liquidated damages will be announced by the Government in due course, which shall be binding on all applicants seeking admission for BPT/MPT programmes during the academic year 2024-25.
2. Revision of fee and other charges, if any, approved by the Committee or State Government/competent Court shall be levied from students seeking admission/admitted during the academic year 2024-25.

**I. Introduction**

Physiotherapy Education while catering to the ever demanding need of technically qualified personnel at National and International levels will boost the career prospects of our students and will empower them with self – reliance, economic freedom and social commitment. Recognizing the shortage of adequately qualified and trained Physiotherapists and the overwhelming demand for them within the Country and abroad.

The main objective of offering the basic B P T degree programme of 4 ½ years duration and MPT programmes of 2 years duration by our College are to produce Graduates having specialized knowledge in human Anatomy, Physiology and Clinical Sciences which will enable them to provide comprehensive Physiotherapy care to all age groups in all situations both in the hospital and in the community. By offering a well planned and well supervised clinical training programme, the students will be enabled and empowered to utilize the

latest technological innovations to provide quality healthcare as well as to conduct result – oriented studies in various settings and utilize the research findings to improve the quality of physiotherapy. The course will also enable them to communicate effectively with individuals, groups, and members of any health care team in order to promote effective interpersonal relationship and collaborative work.

## **ADMISSION**

### **II Number of Seats**

- i. No. of seats: The annual intake of our college is shown in the annexure II
- ii. **All the candidates admitted shall pay the fees fixed by Government of Kerala/ Fee Regulatory Committee and as approved or modified by Competent Authorities.**

### **III Eligibility for Admission**

#### **Academic:**

#### **1) BPT PROGRAMME- (4½ years)**

- (i) Candidates who have passed Higher Secondary Examination of the Board of Higher Secondary Education, Kerala, or examinations recognized as equivalent there to, as approved by Kerala University of Health Sciences Thrissur.
- (ii) Should have passed Higher Secondary examination conducted by Board of Higher Secondary Education, Kerala, or examination equivalent thereto as approved by Kerala University of Health Sciences, Thrissur. Should have separate minimum pass mark for Physics Chemistry and Biology and 50% marks in Biology separately and should have 50% marks in Physics, Chemistry and Biology put together at the final year of the qualifying examination (Plus two)
- (iii) Students applying for admission to B.P.T course should have studied English as a subject in Higher Secondary level.
- (iv) Necessary documents has to be submitted during the time of admission(see Annexure III )

#### **2) MPT PROGRAMME (2 Years)**

- (i) Candidates who passed Bachelor of Physiotherapy examination from any recognized Universities and approved by KUHS and completed/completing 6 months internship on or before 30/10/2024.
- (ii) Necessary documents has to be submitted during the time of admission (see Annexure IV)

#### **3) Admission quota & general conditions**

- Selection of students shall be made on the basis of norms prescribed by Govt. of Kerala/ Kerala University of Health Sciences from time to time.
- 50% of the total seats of the College including reservation will be offered to the Government to be filled from the list prepared by the LBS Centre for Science & Technology, as Merit seats in accordance with merit and reservation principles followed by Government from time to time. In case Government decides not to take up Merit Seats allotment, the same will be allotted and converted as Management seats by the College management.

- Remaining 50% of the seats will be filled by the management on merit basis among which 35% of seats will be filled under management quota and 15% of seats will be filled under NRI quota
- Levying amount towards liquidated damages from candidates discontinuing their studies shall be as in the related clause of prospectus 2024-25 issued by the Director of Medical Education, Trivandrum and as per the final decision of the ASC/Court of Law.
- The cut off date for allotment of seats under Government merit quota for the year 2024-25 shall be as per the understanding with the State Government. The College Management shall be entitled to fill those Government merit quota seats remaining unfilled after the cut off date. (Before closing Admission)

**4) Eligibility Certificates:** Candidates who have passed their qualifying examination from places other than State of Kerala shall produce the Certificate of Eligibility from KUHS and the Migration certificate from the Board / University last enrolled in. This should be submitted at the time of interview for admission.

**Age**

**BPT**

1. Applicants should have completed 17 years of age on the 31<sup>st</sup> December 2024. No relaxation of the minimum age will be allowed.
2. Self attested copy of relevant page of school record namely SSLC/ICSE/CBSE/ certificate showing the date of birth / copy of birth certificate should be produced at the time of admission.

**MPT**

There is no upper age limit

#### **IV. How to Apply**

Application for admission to Bachelor of Physiotherapy/Master of Physiotherapy courses can be registered only online through a single application. The provision for applying online is available at the website [www.bncptvm.edu.in](http://www.bncptvm.edu.in) Submission of more than one application by a candidate will lead to rejection of the applications for the same course submitted subsequent to the first application.

#### **Application Fee:**

##### **BPT**

- (i) The application fee will be Rs.750/- for all candidates, payable through online by using Credit/Debit/Internet Banking facility. Application submission will be completed only after successful payment of Application fee through online.

##### **MPT**

- ii) The application fee will be Rs.1000/- for all candidates, payable through online by using Credit card /Debit card /Internet Banking facility. Application submission will be completed only after successful payment of Application fee through online.

- (vi) Application fee once remitted will not be refunded in any circumstances.

#### **Availability of Prospectus**

### **Submission of Application Form**

- (i) There will be three stages for the submission of Application form and all stages are mandatory. Candidates shall complete all the stages of submission as per the time schedule which will be notified through the website/media.

**Stage 1 -** Entering candidate details online and creating a login id and password.

**Stage 2 -** Online Payment of Application fee using Neft/RTGS /Internet Banking facility.

**Stage 3 -** Completion of Application & submission with College. No need to send any printout in our office.

- (ii) Submission of Application in detail.

- a) Candidate shall visit the official website from [www.bncptvm.edu.in](http://www.bncptvm.edu.in) and click the link **“Admission”**.
- b) The personal details of the candidate have to be filled in the page thus obtained and saved.
- c) Candidates are requested to create a **login Id and Password for future references**.
- d) Click **‘SAVE’** Button, Candidate will be guided to Payment Screen. Application fee can be paid by Debit card /Credit card /Internet Banking facility.

- (iii) On successful payment of Application fee Candidate will be guided to Next Page, Upload the Photo of the candidate (in **JPEG format up to 30 KB size**)

- (iv) Submit and Click Save and Final Confirmation.



## V Preparation of Merit List

### Merit list:

(a) 35% of seats will be filled by management from among the applications received by the management on the basis of merit list prepared based on the marks obtained in the qualifying examination in the core subjects as mentioned in the eligibility criteria.

(b) 15% of seats will be filled from among the applications received from NRI students fulfilling the eligibility criteria on the basis of merit list prepared based on the marks obtained in the qualifying examination in the core subjects as mentioned in the eligibility criteria. as also fulfilling the eligibility norms of NRI quota notified by the State Govt.

**Resolution of tie while ranking:** In case of a tie in the total marks, the marks in Biology will count. If there is still a tie the marks in Chemistry and Physics will be counted. If a tie still exists, the age of the candidate will be taken into account, the elder will be preferred to the younger.

**Validity of the merit list:** The published merit list will be valid till 31/10/2024 or the date up to which the merit list shall be kept alive in terms of instruction/direction of competent authorities

Inclusion in the merit list will not entitle the applicant eligible for admission to the course, unless the applicant satisfy the rules regarding the eligibility for admission and other conditions as laid down in the Prospectus.

Furnishing of false information/particulars would result in the forfeiture of the candidature as well as cancellation of admission to the course, and in addition, will attract the relevant provisions of criminal law of the land.

## VI Preparation of Rank List

- i. BPT: Rank List will be prepared on the basis of marks obtained by candidates for Physics, Chemistry, Biology put together at the final year of the qualifying examination (Plus two)
- ii. MPT: Rank List will be prepared on the basis of marks obtained by candidates for 1<sup>st</sup> year, 2<sup>nd</sup> Year, 3<sup>rd</sup> Year & 4<sup>th</sup> Year BPT mark list (6 months internship is compulsory)

## VII Selection Process

- i. The allotment to Bethany Navajeevan College of Physiotherapy for Bachelor of Physiotherapy/Master of Physiotherapy will be done under the supervision of the Admission Supervisory Committee of the college. The allotment will be strictly based on the rank lists prepared and published in the website based on the marks secured by the candidate.

## VIII NRI Quota

NRI Quota An applicant, who depends upon his/her Father/Mother/ Brothers and Sisters (inclusive of first cousins)/ Husband/Wife/ Brothers and Sisters (inclusive of first cousins) of Father or Mother/Half Brother/Half Sister/Adopted Father or Adopted Mother working abroad is eligible to apply under NRI quota. (As per the G.O (MS) No.243/2014/ H&FWD dated 06.08.2014). Candidates who seek admission under NRI quota in Private Self Financing Medical/Dental colleges should upload documents/certificates as per G.O. (Rt) 375/2020/H&FWD dated.22.02.2020 & G.O (Rt) No.1480/2022/H&FWD dated: 22.06.2022.

The following documents shall be uploaded for NRI Quota reservation (As per G.O.No. 375/2020/H&FWD, Dated 22.02.2020 and G.O (Rt) No.1480/2022/H&FWD, Dated 22.06.2022).

1. Passport copy and Visa attested by the Embassy or Consulate authorities/Green Card/Overseas Citizen of India (OCI) documents of their respective sponsors. The job of the sponsor should be mentioned in any of the above documents.
2. The visa of the Sponsor should be valid till the closing date of admission in respect of Medical and Medical Allied courses.
3. In case, the employment of the sponsor is not mentioned in the above documents, the candidate has to produce the Employment Certificate of the Sponsor attested by the Embassy/Consulate authorities.
4. The Certificates clearly establishing the relationship of the sponsor with the candidate shall be obtained from the Revenue authorities as per the G.O (MS) No. 243/ 14/ H&FWD dated 06.08.2014.

### Note:

a) Relationship should clearly be established. In case relationship is mentioned as Niece/Cousin/Uncle/Aunt only in the space provided for in the certificate, the Village Officer should give an explanation of the relation in the certificate itself. Niece/Cousin/Uncle/Aunt should be explained with clear relationship. The relationship link should be clearly explained. Certificates showing mere Niece/Cousin/Uncle/Aunt without establishing clear relationship link will be rejected. Candidates shall verify the certificate properly before submitting online.

**b) Directives of AFRC from time to time will be applicable to the NRI documents subject to the Government Orders**

c) The candidate shall produce the sworn affidavit from the Sponsor in a stamp paper worth Rs.200/-The same shall also be notarized by the Notary Public, disclosing that the student is dependent of the sponsor and all expenses i.e. tuition fee and special fee, of the candidate for the entire course period will be borne by the Sponsor.



## IX Admission & Payment of Fees

The selected candidates will be informed through SMS in to the registered mobile number with us.

- i. The students shall pay all fees of the 1<sup>st</sup> year of the course at the time of admission. Candidates who cancel their admission before the closing date of admission are eligible for refund of fees.
- ii. A request for refund of fees along with a copy of allotment memo and fee remitted receipt should be submitted to the Director, BETHANY NAVAJEEVAN COLLEGE OF PHYSIOTHERAPY in the format prescribed in Annexure 1 (with proof). Request for refund will not be considered after closing date of admission.
- iii. Fees shall be collected only the approved tuition fee and special fee through online payment /DD/RTGS/IMPS etc. from the candidates.

**All other fees due to statutory bodies / KUHS as notified by the State Government.** Selected Candidates should remit 1<sup>st</sup> year fee through online payment, against the acceptance of the admission to the allotted seat. If the amount is not remitted within the time prescribed, the application of the Candidate will be removed from the admission process.

**If any candidate discontinues the course, after closing of admission as notified by the authority, the candidate has to pay the tuition fee of the remaining course period. The Collection of Liquidated damages shall be as per the final decision of the AFRC / Court of Law**

**X Special Instructions.**

- a. **Ragging:** Ragging in any form is strictly prohibited in our college. Bethany Navajeevan College of Physiotherapy committed to abolish ragging in our campuse. Hence any student who indulges in any form of ragging will be subjected to penal action as per provisions of law. Also the student will be expelled from the college as detailed in the law concerned and as per Honorable Supreme Court of India directions in this regard.
- b. Any other items not specifically covered in this prospectus will be decided by the Controller of Admissions.
